6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Remove all sources of ignition. Increase ventilation. Evacuate all unprotected personnel. Do not breathe dust. Wear respiratory protection and full protective clothing to minimise exposure. Sweep up material avoiding dust generation - dampen spilled material with water if suitable to avoid airborne dust, OR where possible use dustless methods such as vacuum to collect the material; then transfer material in to suitable vapour tight labelled containers for subsequent recycling or disposal. Dispose of waste according to applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of dust, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dust in the work atmosphere. Establish good housekeeping practices. Remove dust accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating dust clouds. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities. Avoid exposure. Do not handle until all safety precautions have been read and understood. It is recommended that pregnant or breastfeeding women should not handle this product unless adequate exposure protection can be assured at all times. Conditions for safe storage, including any incompatibilities

Store away from incompatible materials such as materials that support combustion (oxidising materials). Store in suitable, labelled containers. Inspect periodically for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area.
