4. FIRST-AID MEASURES

Inhalation

Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Remove all sources of ignition. Increase ventilation. Evacuate all unprotected personnel. Do not breathe dust. Wear respiratory protection and full protective clothing to minimise exposure. Sweep up material avoiding dust generation - dampen spilled material with water if suitable to avoid airborne dust, OR where possible use dustless methods such as vacuum to collect the material; then transfer material in to suitable vapour tight labelled containers for subsequent recycling or disposal. Dispose of waste according to applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of dust, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dust in the work atmosphere. Establish good housekeeping practices. Remove dust accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating dust clouds. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities. Avoid exposure. Do not handle until all safety precautions have been read and understood. It is recommended that pregnant or breastfeeding women should not handle this product unless adequate exposure protection can be assured at all times. Female personnel planning pregnancy should be made aware of the potential risks.

Conditions for safe storage, including any incompatibilities

Store in a well ventilated area away from heat and sources of ignition, out of direct sunlight and moisture. Take precautions against static electricity discharges. Use proper grounding procedures. Store away from incompatible materials such as materials that support combustion (oxidising materials). Store in suitable, labelled containers. Inspect periodically for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area. Ensure that storage conditions comply with applicable local and national regulations.

Appropriate Engineering Controls

13. DISPOSAL CONSIDERATIONS

Disposal considerations

Product Disposal:

Product wastes are controlled wastes and should be disposed of in accordance with all applicable local and national regulations. The product should be rendered non-hazardous before being sent to a licensed landfill facility. In this specific case the product is a combustible substance and therefore can be sent to an approved high temperature incineration plant for disposal.

Personal protective clothing and equipment as specified in Section 8 of this SDS must be worn during handling and disposal of this product. The ventilation requirements as specified in the same section must also be followed, and the precautions given in Section 7 of this SDS regarding handling must also be followed.

Do not dispose into the sewerage system. Do not discharge into drains or watercourses or dispose where ground or surface waters may be affected.
